GEORGIA MOUNTAINS REGIONAL COMMISSION

Georgia Mountains Regional Commission Mission Statement:

To serve the local governments of the Georgia Mountains Region by improving the quality of life through economic development, community planning, information technology, and workforce development to support and enhance the region's prosperity.

The Georgia Mountains Regional Commission (GMRC) is a sub-state district created by local governments in 1962 under provisions of Georgia Enabling Law. The purpose of the GMRC is to locally promote and guide development of human, natural, physical, social and economic resources in the Georgia Mountains Region. The area covers 3,500 square miles, and includes Banks, Dawson, Forsyth, Franklin, Habersham, Hall, Hart, Lumpkin, Rabun, Stephens, Towns, Union, and White Counties.

The GMRC offers a wide variety of services to its 51 local governments, which include 13 counties and 38 municipalities. The GMRC works with these entities to formulate goals and strategies for area growth and development. Upon request, the GMRC provides a variety of technical assistance that will improve community services and the quality of life for Georgia Mountains residents.

The GMRC is guided by a forty-four (44) member Council and is composed of individuals appointed by the Governor, Lieutenant Governor, Speaker and one county elected official, one city elected official and one private sector individual from each of our 13 counties. City, County and private sector representatives are chosen by the cities and counties they represent. The Council is responsible for all policy decisions.

The GMRC interacts with many agencies at regional, state, and federal levels. These agencies work with the GMRC to coordinate and complement the delivery of services to governments and citizens of the Georgia Mountains area.

The GMRC is funded by a variety of sources, including federal, state, and local funds. The annual RC budget is reviewed and approved by the Council.

The GMRC focuses its broad scope of responsibility through the following departments: Planning, Economic Development, Workforce Development, Information Services, Finance and Administration.

On July 1, 2009, Georgia Mountains Regional Development Center was renamed Georgia Mountains Regional Commission. This event was part of the State of Georgia's restructuring of its regional boundaries.

Description:

Utility Service trucks are a mainstay for Distribution/Collection activities. Able to carry both a crew and the materials needed for virtually any project, these vehicles increase the efficiency of operations. This is a replacement vehicle, so fleet size is unchanged. The vehicle that is scheduled to be replaced has only 28 points, and large vehicles typically require 30. However, the to-be-replaced vehicle is a 2006 model that does not have a trailer air brake supply, and most of our trailers today require this feature to safely move them.

In 2005, the City contracted with Jerry Weitz & Associates, Inc. for \$40,000 to complete a Capital Improvement Element (CIE) for Public Safety and Parks & Recreation. The purpose was to provide the planning to support an impact fee program for Public Safety (Police & Fire) and Parks & Recreation. The 2006 CIE was based on the resident and functional population at that time. Just as with the City's Comprehensive Plan, the CIE must be updated to remain relevant. With an update, previous noted deficiencies that have been addressed as well as new projects to accommodate new (and expected) growth can be accounted for. The CIE serves as the foundation for fees impacting servicing delivery, specifically Public Safety and Parks & Recreation. Given population growth and development trends since 2005/2006 and public improvements completed since adopting impact fees, it is in the City's best interest to update its CIE. Such facility improvements as the Public Safety Complex were not accounted for in the 2005/2006 CIE, and as such, deficiencies were noted and facilities identified to meet those deficiencies deemed ineligible for impact fees. For example, the 2006 CIE determined that the City was deficient one fire station (Fire Station #5) for its functional population. The new fire station, which was completed in 2010, is comprised of enough facility space to account for that which replaced the previous Station #1 plus meet the deficiency for the population at the same time and exceed the level of service needs within the five-year planning period of the 2006 CIE. Thus, updating the 2006 CIE could render projects previously determined to be impact fee ineligible to now be impact fee eligible. In short, updating the 2006 CIE improves relevancy and minimizes risk of increasing deficiencies in meeting levels of service and thereby rendering imminent and future Police, Fire and Parks & Recreation projects impact ineligible.

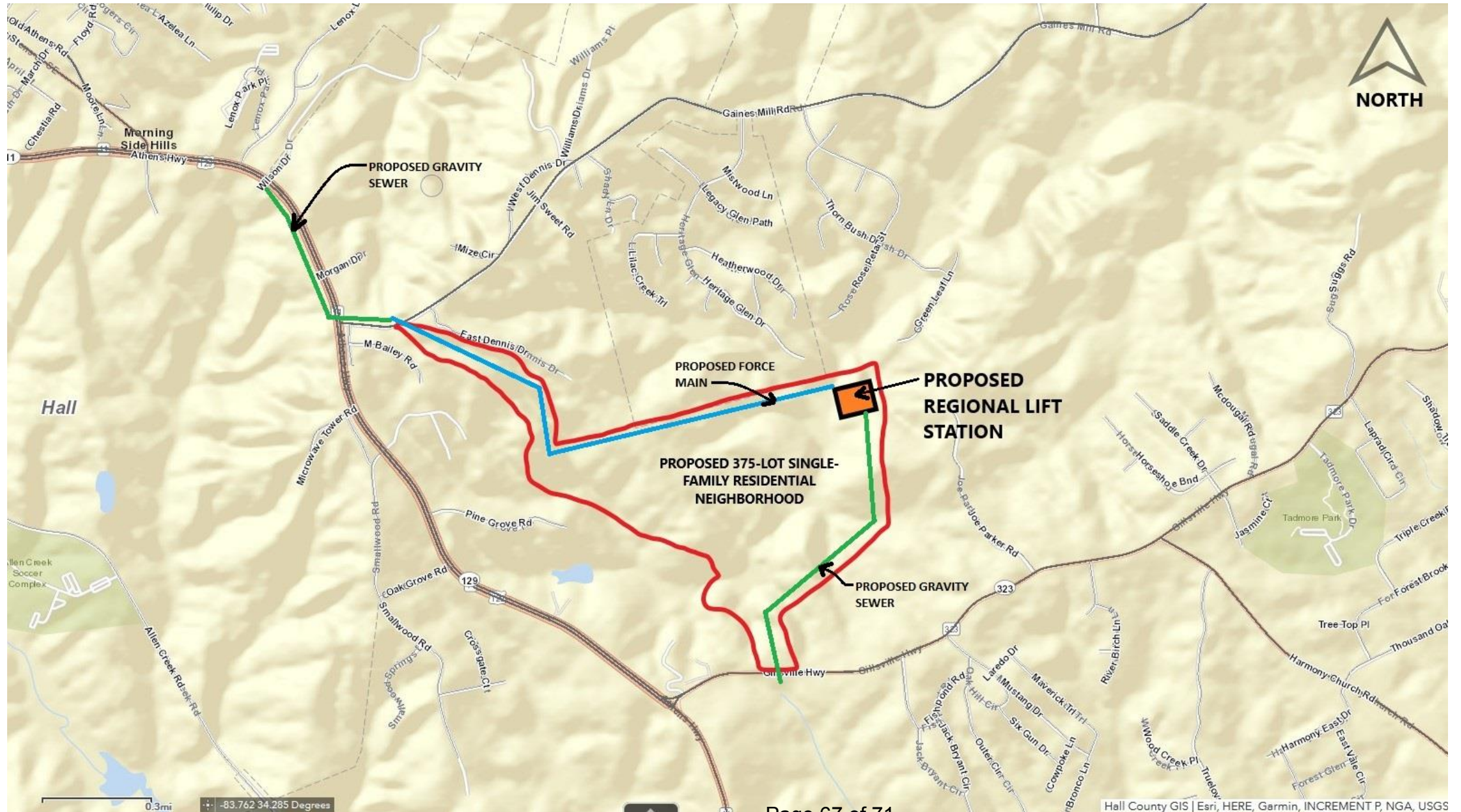
