**AUTHORIZATION TO EXECUTE FIRST AMENDED PARKING, SIGN AND SALE
AGREEMENT WITH THE ARTS COUNCIL, INC.**

WHEREAS, the City of Gainesville, Georgia ("the City") purchased from The Arts Council, Inc. ("the Arts Council") real property located on Broad Street in the City, which property is more particularly described in Exhibit "FIRST A" in the attached First Amended Parking Sign and Sale Agreement ("the First Amended Agreement") as a part of the City's economic development plan to encourage further development in the downtown area; and

WHEREAS, the City wishes to continue its plans to encourage downtown development and support the efforts of the Arts Council in accordance with that Parking, Sign and Sale Agreement between the City and the Arts Council dated January 13, 2018 ("the 2018 Agreement"), a copy of which is attached as Exhibit "FIRST B" to the First Amended Agreement; and

WHEREAS, the City wishes to restate and amend the 2018 Agreement by execution of the First Amended Agreement.

NOW, THEREFORE, BE IT RESOLVED THAT the governing body for the City of Gainesville hereby authorizes the Mayor, City Manager, and City Attorney to execute a document in substantially the same form as the First Amended Agreement and to sign such additional documents as necessary to effectuate the approval set forth in this Resolution.
